

## **EXECUTIVE ORDER D-660-63**

## Relating to Exemptions Under Section 27156 of the California Vehicle Code

Cobb Tuning
Nissan Big SF Intake System and Nissan Redline Carbon Fiber Big SF Intake System
Part Numbers 7C1150 and 7C1250

Pursuant to the authority vested in the California Air Resources Board by Section 27156 of the Vehicle Code; and

Pursuant to the authority vested in the undersigned by Section 39515 and Section 39516 of the Health and Safety Code and Executive Order G-19-095;

IT IS ORDERED AND RESOLVED: That installation of the Nissan Big SF Intake System and Nissan Redline Carbon Fiber Big SF Intake System, manufactured and marketed by Cobb Tuning, 2311 West Rundberg Lane, Suite 500 Austin, Texas 78758, has been found not to reduce the effectiveness of the applicable vehicle pollution control systems and, therefore, is exempt from the prohibitions of Section 27156 of the Vehicle Code for 2009 to 2018 Nissan GT-R 3.8L.

The Nissan Big SF Intake System and Nissan Redline Carbon Fiber Big SF Intake System replace the stock air intakes for both the driver and passenger sides with new tubes and cone shaped air filters without air boxes. The new system operates as an open element system. Both systems are the same except for the tube material. The Nissan Big SF Intake System (7C1150) uses tubes made from aluminum while the Nissan Redline Carbon Fiber Big SF Intake System (7C1250) uses tubes made from carbon fiber. For both systems, the stock MAF sensors are installed in the new tubes in the similar location and orientation as stock. The ECU is not modified as part of the installation of these kits and remains stock.

This Executive Order is valid provided that the installation instructions for the Nissan Big SF Intake System and Nissan Redline Carbon Fiber Big SF Intake System will not recommend tuning the vehicle to specifications different from those of the vehicle manufacturer.

Changes made to the design or operating conditions of the Nissan Big SF Intake System and Nissan Redline Carbon Fiber Big SF Intake System, as exempted by the California Air Resources Board, that adversely affect the performance of the vehicle's emission control system shall invalidate this Executive Order.

This Executive Order shall not apply to any Nissan Big SF Intake System and Nissan Redline Carbon Fiber Big SF Intake System advertised, offered for sale, sold with, or installed on a new motor vehicle prior to or concurrent with transfer to an ultimate purchaser.

Marketing of the Nissan Big SF Intake System and Nissan Redline Carbon Fiber Big SF Intake System using any identification other than those shown in this Executive Order or marketing of the Nissan Big SF Intake System and Nissan Redline Carbon Fiber Big SF Intake System for an application other than those listed in this Executive Order shall be prohibited unless prior approval is obtained from the California Air Resources Board.

This Executive Order does not constitute any opinion as to the effect the use of the Nissan Big SF Intake System and Nissan Redline Carbon Fiber Big SF Intake System may have on any warranty either expressed or implied by the vehicle manufacturer.

Exemption of the Nissan Big SF Intake System and Nissan Redline Carbon Fiber Big SF Intake System shall not be construed as an exemption to sell, offer for sale, or advertise any component of the assembly as individual devices.

This Executive Order is granted based on information submitted by Cobb Tuning, including emissions test data.

The California Air Resources Board reserves the right in the future to review this Executive Order and the exemption provided herein to assure that the exempted add-on or modified part continues to meet the standards and procedures of Title 13, California Code of Regulations, Section 2222, et seq.

THIS EXECUTIVE ORDER DOES NOT CONSTITUTE A CERTIFICATION, ACCREDITATION, APPROVAL, OR ANY OTHER TYPE OF ENDORSEMENT BY THE CALIFORNIA AIR RESOURCES BOARD OF ANY CLAIMS OF THE APPLICANT CONCERNING ANTI-POLLUTION BENEFITS OR ANY ALLEGED BENEFITS OF THE NISSAN BIG SF INTAKE SYSTEM AND NISSAN REDLINE CARBON FIBER BIG SF INTAKE SYSTEM.

No claim of any kind, such as "Approved by the California Air Resources Board", may be made with respect to the action taken herein in any advertising or other oral or written communication.

Violation of any of the above conditions shall be grounds for revocation of this order. The order may be revoked only after a ten-day written notice of intention to revoke the order, in which period the holder of the order may request in writing a hearing to contest the proposed revocation. If a hearing is requested, it shall be held within ten days of receipt of the request and the order may not be revoked until a determination is made after the hearing that grounds for revocation exist.
