



EXECUTIVE ORDER D-660-14

Relating to Exemptions Under Section 27156  
of the California Vehicle Code

Cobb Tuning  
Cobb Subaru 20g Turbocharger

Pursuant to the authority vested in the California Air Resources Board (CARB) by Section 27156 of the Vehicle Code; and

Pursuant to the authority vested in the undersigned by Section 39515 and Section 39516 of the Health and Safety Code and Executive Order G-19-095;

IT IS ORDERED AND RESOLVED: That installation of the Cobb Subaru 20g Turbocharger, manufactured by Cobb Tuning, 2311 West Rundberg Lane, Suite 500, Austin, Texas 78758 has been found not to reduce the effectiveness of the applicable vehicle pollution control systems and, therefore, is exempt from the prohibitions of Section 27156 of the Vehicle Code for the 2006 to 2019 Subaru vehicles with the 2.5L turbocharged engine listed in Exhibit A.

The Cobb Subaru 20g Turbocharger is a direct fit replacement turbocharger for the stock turbocharger that utilizes all stock sensors and fittings in their original locations. The Cobb Subaru 20g Turbocharger provides a slight performance increase and durability over the stock turbocharger by utilizing superior bearings and slightly larger internal components. There is no tune change required in the ECU.

This Executive Order is valid provided that the installation instructions for the Cobb Subaru 20g Turbocharger will not recommend tuning the vehicle to specifications different from those specified by Cobb Tuning.

Changes made to the design or operating conditions of the Cobb Subaru 20g Turbocharger, as exempted by CARB, which adversely affect the performance of the vehicle's pollution control system shall invalidate this Executive Order.

This Executive Order shall not apply to any Cobb Subaru 20g Turbocharger advertised, offered for sale, sold with, or installed on a new motor vehicle prior to or concurrent with transfer to an ultimate purchaser.

Marketing of the Cobb Subaru 20g Turbocharger using any identification other than those shown in this Executive Order or marketing of the Cobb Subaru 20g Turbocharger for an application other than those listed in this Executive Order shall be prohibited unless prior approval is obtained from CARB.

This Executive Order does not constitute any opinion as to the effect the use of the Cobb Subaru 20g Turbocharger may have on any warranty either expressed or implied by the vehicle manufacturer.

Exemption of the Cobb Subaru 20g Turbocharger shall not be construed as an exemption to sell, offer for sale, or advertise any component of the assembly as individual devices.

This Executive Order is granted based on information submitted by Cobb Tuning, including emissions test data.


CARB reserves the right in the future to review this Executive Order and the exemption provided herein to assure that the exempted add-on or modified part continues to meet the standards and procedures of Title 13, California Code of Regulations, Section 2222, et seq.

THIS EXECUTIVE ORDER DOES NOT CONSTITUTE A CERTIFICATION, ACCREDITATION, APPROVAL, OR ANY OTHER TYPE OF ENDORSEMENT BY CARB OF ANY CLAIMS OF THE APPLICANT CONCERNING ANTI-POLLUTION BENEFITS OR ANY ALLEGED BENEFITS OF THE COBB SUBARU 20g TURBOCHARGER.

No claim of any kind, such as "Approved by the California Air Resources Board", may be made with respect to the action taken herein in any advertising or other oral or written communication.

Violation of any of the above conditions shall be grounds for revocation of this order. The order may be revoked only after a ten-day written notice of intention to revoke the order, in which period the holder of the order may request in writing a hearing to contest the proposed revocation. If a hearing is requested, it shall be held within ten days of receipt of the request and the order may not be revoked until a determination is made after the hearing that grounds for revocation exist.
